Maintain a safe environment while enforcing the rules and ensuring customer satisfaction. Position requires current lifeguard, first aid and CPR/AED certifications through the American Red Cross. Will train, therefore no previous experience required, but excellent customer services and communication skills are required. Must be able to swim, and daily training in and out of the water is required. Will train. Conversational English Language skills are required. Schedule varies, including weekends and holidays.

HOUSING & TRANSPORTATION

Host Employer assists with housing, and it will be a Condo, Hotel or House.

- **Housing** is required for the job placement for the duration of your program.
- **Participants** may be required to sign a housing agreement. By signing the program information guide and/or housing agreement, participants are agreeing to stay at housing that has been pre-arranged for the entire length of the agreement.
- **You** may be required to make initial housing payments upon arrival, which could include advance rent payment, security deposit & setup fee. After that time, housing will be paid weekly by payroll deduction.
- **Any** damage to the property will result in participants paying the cost as determined by the housing management.
- **Detailed** housing arrangement will be disclosed by GEC prior to arrivals.
- **Housing** cost is \$100 - \$120 per week and paid through weekly payroll deduction.
- **Your** Host Employer will assign rooming lists based on arrival/departure dates and specific roommates may not be guaranteed.
- **When** offered the placement, by signing the Work Agreement and Program Information Guide, exchange visitors assume responsibility to read the housing rules and abide by all terms and conditions.
- **Various** Transportation options available and might include Public Transportation, Taxi/Shuttle Service, & Ride Share (Uber/Lyft). Your Host Employer provides transportation to and from job site at no charge.

MASSANUTTEN, VIRGINIA

McGaheysville (Massanutten) is a small community located in Rockingham County. It is located along U.S. Route 33 between Penn Laird and Elkton and sits at the base of Massanutten Mountain. McGaheysville is located near the south fork of Shenandoah River in the heart of the Shenandoah Valley. The land to the immediate south of the town consists primarily of farmland but beyond that is the mountainous Shenandoah National Park. It is nestled between the Blue Ridge Mountains on the east and the Allegheny Mountains on the west. It boasts diverse outdoor recreation, such as skiing, canoeing, kayaking, rafting or tubing.

Massanutten Resort on Massanutten Mountain is just to the north of the town. Massanutten Resort has skiing, tubing, and a large indoor/outdoor waterpark for year-round fun and entertainment. McGaheysville was named for surveyor Tobias Randolph McGahey, who came to the area as part of a Scotch-Irish colonization effort in 1801. Shortly thereafter he married innkeeper Eva Conrad, at whose tavern he had previously spent the night. In 1802 he established a post office using the name "McGaheysville" and gave the town its name.
